



EMINENCE Royalty

he first Emir of Wase was HASSAN (1817-1827). Hassan was then the Madaki of Bauchi and Yakubu the Emir of Bauchi, the area from the gate of Bauchi to the boundary of Zauzau. Eight years after the wars that established Bauchi town, Madaki Hassan asked Yakubu for permission to travel out and erect a town near Goron Dutse (Wase Rock) where his father the liked and told him much about. Wase was eventually founded with permission of Shehu Usmanu. It took only six (6) days to clear the area after having a letter from Shehu Laminu to start Friday prayers in Wase; which informing him he would arrive and he was hitherto performed only in should therefore transfer his allegiance from the sultan of sokoto to him (Shehu Lamidu). He gathered all title holders and informed them of the content of the letter but did not consent to waging a war against Shehu Laminu of Borno . On the arrival of Madaki Hassan from Wase, it was agreed that since the land was not given to them by Shehu Laminu of Borno they should not therefore follow him. Soon after a letter was received from Sultan of Sokoto asking him to go and start fighting

Bauchi. The battle ended with success on Yakubu's side but lost of 84 famous warriors apart from other body found (Fulanis and others) which were many. The exercise is known as (Yakin kalunbu) after which the emir of Bauchi turbaned M. Adamu a servant of late Madaki Hassan as the new Madakin Bauchi. The lost of Madaki Hassan however remained a great blow to the Emir of Bauchi for he was his first lieutenant and adviser on all issues, and example of which occurred in advising Yakubu to fight against Shehu Laminu even before the letter from the Sultan of sokoto reached Bauchi for they argued, they could not serve two masters. It was said that Hassan was in fact so great that all other title holders with the Emir used to stand up at his appearance and sit after him. He was survived by fourty children, thirtysix males and four females; and left behind 3,000 slaves. He reigned for 10 years. The grave of Madaki Hassan the son of Giwa is 1 mile from Kiyawa. Its one and half mile from Fake to the grave. Gantsa is west of Fake and Kalgo. There is a big tree there which give shade to the grave. There was no grass there, according to M. Ahmadu. After the reigned of Madaki Hassan then Wase was ruled by the 13 following Emirs one after







Legend of the Royal Chieftains that made Sokoto Caliphate

here is a legendary belief that the success of the Sheikh Usman Dan Fodio 1804 jihad began from the attitude of the Hausas of Katsina and Katsina itself, who were not sorry to see the Gobirawa in difficulties. Gobir and the Gobirawa in the 1804 was the hot seat of opposition to Usman Dan Fodio and his Islamic revival. Legend states that although Gobir and the Gobirawa made an appeal for help to Katsina and the Katsinawa, Katsina and the Katsinawa did not send any help to Gobir king Yunfa before the battle of Tabkin Kwatto.

According to the legend, after the battle, and defeat of Gobir, however, Katsina and the Katsinawa seemed to have been quick to perceive that Shehu Usman Dan Fodio had constituted a new force which might threaten them as well after Gobir. King of Gobir Yunfa had earlier before the war pointed the moral in a letter which he wrote to his entire brother Chiefs, including the Katsina king. The key point of the letter's message, according to the legend, was the warning that there had been a small fire in Gobir, which had flared out and burnt the Gobir king because he neglected to stamp it out, therefore, let other kings be warned by his experience.

Yunfa's letter probably reached the chief of Katsina before the conciliatory message which Shehu sent at about the same time at the beginning of his Islamic revivalist call to the kings. The source of Yunfa's conflict with the Shehu, according to legend, was that when Shehu's letter was brought to Yunfa, he did not hesitate, as did the chiefs of

Kano and Zazzau, but simply tore it up. The reply, according to the legend, was: 'Even so', Bello wrote afterwards, 'did God tear up his kingdom and his power.'

In Katsina, as in other Hausa States, Yunfa's message was initially complied with as it was what gave the signal for the outlawing of the Islamic reformers and start of hostilities to the Fulani revivalists. This was believed to have been the reason that 'when Sarkin Katsina heard what had happened to Sarkin Gobir he commanded his chiefs to make war upon all who were allied to Shehu.

Meanwhile their comrades who had remained behind in Katsina and Daura had alerted the Hausa chiefs sufficiently to cause them to try to join forces with the chief of Kano with the object of crushing the Fulani uprisings. Contingents led by Sarkin Katsina and Sarkin Daura actually set out for Kano, but found their way and since the start of the jihad they barred by strong Fulani forces under had been maintaining that he was in Dan Tunku, who later became Emir of error and guilty of deceiving and Kazaure, he defeated the Katsina-Daura forces and compelled them to turn back.

Among Shehu's personal followers was a Fulani called Umaru Dallaji. After this, still accompanied by Umaru Dallaji and Muhammadu Ashafa now with the support of another influential Fulani called Muhammadu Dan Alhaji, Bello consolidated his success by capturing many other Hausa towns and subduing a group of local Fulani who had been assisting the Hausa regime. When southern Katsina (which at this time also included the Chafe-Gusau-Kanoma area) had been secured, Bello decided that the time had come for him to return to Shehu. He therefore presented flags to Umaru Dallaji and Muhammadu Dan Alhaji, as symbols of their authority, and ordered them to move north, into the centre of the State, and attack Awai and Ranko, while Muharnmadu Ashafa remained in Katsina Laka to consolidate the territory that had already been won. Ranko and Awai soon fell. The Hausas, under the Ubandawaki, launched a counterattack against Ranko, but this was repulsed and they were compelled to fall back on the capital. The way was now open for the decisive blow.

But before any attempt was made to deliver it, another powerful ally was recruited to Shehu's cause, namely Umaru Dumyawa, the chief of the Sullubawa in Katsina. The Sullubawa, like the Toronkawa, were not pure Fulani but part Fulani and part Mandingo. They had come with the Fulani from Senegal, however, and they shared their outlook and way of life. ho are chiefs and emirs and where does their authority and legitimacy comes from? Are there differences between those rulers referred as emirs and those called chiefs? Answers to these questions lead to different experiences and antecedents the traditional leadership institution has been subjected to in the last centuries across Nigeria.

regimes changes have included either the introduction of appointment or selection systems for chiefs.

Karlstrum and Ribot reported in 1996 and 2002 respectively that the colonial changes to the traditional leadership institution are however in contrast with the nature of the traditional leadership institution in pre-colonial era. According to the Karlstrum and Ribot report, before the arrival of the colonialists, the traditional leadership institution and structure were such that chiefs exclusively derived their authority and legitimacy either as descendent of a great ruling ancestor or on the basis of membership in a particular ruling family.

Moto explained in 1998 however that the alterations regarding the basis of claims to chieftaincy masterminded by colonial and post-colonial regimes, notwithstanding the right to chieftaincy on the basis of descent have persisted and by and large, remain the dominant means of ascending to a traditional throne in most areas where the institution has survived. This, according to Moto, is the exclusive means for individuals to legitimately ascend to traditional leadership position.

It is against this backdrop that chieftaincy is predominantly defined in terms of tradition. According to Lule (1995) tradition is something done or respected according to custom from generation to generation. Senyonjo (2004) sees tradition as "any culture that was created or pursued in whole or in part by past generations and that has been accepted and presented, in whole or

1979 defines a chief as "a traditional head of an ethnic unit."

Senjonyo (2004:2) explains therefore, that chiefs are the heart of customs and cultures, in the sense that they play a prominent role in their effort to preserve them; they are variously described as guardians of traditional norms, values and practices that are respected in any particular community from generation to generation, and as such they are important channels through which social and cultural change can be realized. Thus, chiefs are actors and embodiment of customary decision making institutions.

According to Oba Lamidi quoted in the Nigerian compass of 12th Dec, 2010, Chiefs are categorized into two, namely:

Those full time executive traditional title-holders who are exercising the executive roles before Nigeria was born and

The holders of tittles or positions created and recognized by Law with specific function.

The difference between the words 'Chief' and 'Emir' can be understood in reference to Emir as a title of various Muslim chiefs or rulers. Emir is accordingly associated with a dynasty's leader, monarch, chief, crown, head, king, emperor, tsar, suzerain etc.

According to the website www.meriamwebster.com, an Emir, sometimes translated 'Amir' or 'Ameer' is an aristocratic or noble and military title of high office used by Muslims. Emir is an Islamic religious reference to a society's political leader, ruling in consultation with the scholar-clerics, known as the Ulama and through whom a judicial committee consisting of judges known as Khadi and their courts form







These steps, if applied effectively, can potentially curb the birth of a bigger threat. In other words, we as a people need to be proactive and ready to act when the need arises. I'm not implying for people to start taking laws into their hands, not at all. I am suggesting that being able to detect a threat in time and reporting a suspicion to the appropriate body can save lives, and potentially get the culprits apprehended.

Peaceful co-existence and religious tolerance imply the capacity to live together in harmony. This calls for nonviolent ways of resolving conflict. Nigeria is a country with a population believed to be over 150 million consisting of various ethnic groups. Religion often coincides with the ethnic groups, but not always. Hausa-Fulanis in the north are Muslims and the Ibos in the South-East are mainly Christians. However, the Yorubas in the South-West are both Muslims and Christians with the Muslims slightly in the majority. Nonetheless, there is a fair amount of inter-marriage amongst the

No country can hope to establish lasting conditions for peace and tolerance unless it finds ways of building mutual trust between its citizens. Inclusive education promotes mutual understanding, respect, tolerance and dialogue. Literacy opens new opportunities and skills for all.

humanitarian and developmental issues facing Northern Nigeria was recently the topic of discussion and pledge for resources and action at the recent Northern Nigerian traditional leaders conference held at Musa Yaradu'a Indoor Sports Hall, Murtala Square, Kaduna, on 10th and 11th October 2018. The importance and urgency of the conference was highlighted by the fact that it was organized by the Federal Ministry of Education, Universal Basic Education Commission, National Commission for Mass Education in collaboration with UNICEF and the Sultan Foundation for Peace and Development, according to reports by sunnewsonline.com

Among the key issues that made the conference a most crucial undertaking in the North was first, the acknowledgment of the alarming statistics by UBEC that there are now in Nigeria, 13.2 million out of school children, out of which, according to UNICEF Director, Pernille Ironside, quoted by sunnewsonline.com, 69 percent of the total are in Northern Nigeria. Second was the report by Leadership newspaper that 19 Emirs are to sign 'Commitment for Action' on out of school children. Third was the report by Blueprint newspaper that UBEC is to release 142 billion naira to states for child. Fourth the UNICEF'S warning reported by the Punch newspaper that Nigeria is losing out on literate, skilled workforce as a result of having 13.2 million out of school children in the Nigeria. The fifth is the presence of important dignitaries at the occasion, which included Minister of Information Alhaji. Lai Mohammed, representative of Nigeria's minister of education, Malam Adamu Adamu, UNICEF, the Executive

The sunnewsonline.com, reported that United Nations Children Fund (UNICEF), Deputy Representative, UNICEF Nigeria, Pernille Ironside said 69 percent of the figure were northern children, with Bauchi state having the highest number of out-of-school children at 1.1 million and Katsina coming in second with 781,500 children out of school, Ironside said.

Sunnewsonline.com quoted Ironside saying, "In 1999, Nigeria took a bold step by declaring its commitment to provide free basic education for all children. This commitment was followed by the establishment of the Universal Basic Education Commission in 2004 to enable the

Government to fulfill its commitment to provide free basic education for all children," raising concerns also that "while these are commendable actions towards guaranteeing the right to education for all Nigerian children, we at UNICEF are concerned about the slow progress."

What highlighted at the occasion how the conference renews education roles for emirs was the speech of the sultan of Sokoto and Chairman of the conference, His Eminence, Alhaji Muhammad Sa'ad Abubakar II, who, quoted by the sunnewsonline.com while reacting to UNICEF Drector Ironside, stated that "the issue of out-of-school children in Nigeria today with Northern States contributing a very large percent of the problem was not only worrisome, but a great burden on their collective conscience."

The following statement by the Sultan of Sokoto as reported by the sunnewsonline.com highlighted further the focus of the traditional leadership on their concern over the issue:

November, 2018 marks 30th years since the irreparable lost of a royalist per excellence, Sir Siddiq Abubakar III (1903–1988) who was a Nigerian Muslim leader. He served as the sultan of Sokoto between the year 1938 and 1988.

Siddiq Abubakar III Born in the year 1903 and Died in late 1988, aged 85 years.

He was born at Dange, on 15th March, 1903, same day on which the British finally subdued the Sokoto Caliphate Son of Usman Shehu, grandson of Mu'azu Dan Bello, direct descendent of Usman Dan Fodio. Sir Abubakar III is the fourth heir to the two century-old throne founded by his ancestor, Sheikh Usman Dan Fodio (1754-

Sir. Abubakar III had Islamic Education. He held several administrative posts before succeeding his uncle, Hassan Ibn Muazu, at age of 35 in the year 1938, he was appointed as a local authority councillor of the Sokoto Native Administration (Head of Talatan Mafara).

He distinguished himself by his administrative competence and the able way he dealt with appeals from traditional courts and supervised district and village heads. He held the title of Saurdauna of Sokoto until 17th June, 1938, when he became the 17th Sultan of the great Sokoto Caliphate.

As the 17th Sultan of Sokoto (Sarkin Musulmi), he became the most important Islamic personality at the south of the Sahara, and

A Little Insight into the oldest Royal Chamber of **Zazzau (Takon Giwa)**

aria is one the seven Hausa nature. The materials used for the States (Hausa Bakwai). The state of Zazzau was said to have been founded by Gunguma (Habe Ruler). Gunguma was also said to be the Son of Bawo and grandson of legendary Bayajidda. He began a line of sixty Habe kings and queens of Zazzau. The twenty second king whose name is Bakwa Turunku moved the people to the foot of Kufena Hill where the new capital was built. The present location of the palace of Zazzau was chosen by Amina and Zanaki. But the date of which the palace was constructed is yet to be ascertained even though historians placed it well ahead of the Zaria city mosque.

Zazzau emirate palace has undergone an unprecedented physical development but to some extent the palace retained some of its original character amongst which is the Takon Giwa. Takon Giwa is the only outstanding structure traditional structure that remained functional. The building was originally conceived to as the council chamber, king's apartment among other things. The building is characterized by Old Majalisa, King's apartment, and council chamber. The old Majalisa has a door connecting it to the king's apartment which technically logical in easy access to both in times of need while others served as courtvard.

Takon Giwa stands unique in the mist of newly constructed chambers which were modern in natural cooling system during hot season and warm during harmattan. Takon Giwa serves as an important edifice that takes attention of visitors to the palace especially the foreigners that was why even Prince Charles on his courtesy call to the palace was received in Takon Giwa. Architects and structural engineers were always fascinated with the level of precision demonstrated by the traditional builders of Zazzau

The emir of Zazzau and his council must be commended for their love of culture and their insistence on maintaining at least one of the oldest royal chambers of Kasar Hausa. The local traditional builders must be brought back to their duty of taking care of such traditional buildings within the palace of Zazzau for posterity.

Sunday 29th October, 2006 at exactly 11:30am local time, Aviation Development Company (ADC) Airlines flight 53, Boeing 737 with registration number 5N-BEF was a scheduled passenger flight that crashed at "Tungar Magaji" shortly after the plane takeoff from the Nnamdi Azikiwe International Airport, Abuja-Nigeria, on its way to Sultan Abubakar III International Airport, Sokoto. Late Emir of Katsina Alhaji (Dr) Muhammadu Kabir Usman borrowed the title of Sardauna from its base. Sokoto for the first time in Katsina, honoured and turbaned the late former Inspector General of Police, Alhaji (Dr) Ibrahim Ahmadu Commassie GCON who happened to become the first Sardaunan Katsina in the year 2000.

The present Emir of Katsina Alhaji (Dr) Abdulmumini Kabir Usman honoured and turbaned Senator Ibrahim M. Ida, CON with the title of new Sardaunan Katsina on 13th October, 2018.

The occasion was attended by many personalities and some were represented in felicitation with the new Sardauna.

Family Background of the New Sardaunan Katsina

The new Sardauna was among the children of Late Malam Muhammadu Maude Bello (Maisa'ida), popularly known as Saje Mamman Ida, the late Maisa'ida is of Yarimawa Fulani lineage, called Fulata-Borno.

The great grandfather of the new Sardauna settled in Borno after a trip to Mecca from Holy Pilgrimage. Later on, Yarima Inti, who was a pastoralist, left Borno with some friends and relations down to the present Ingawa town in Katsina State.







Open Letter to his Eminence Sultan of Sokoto on Increasing Clashes Between Herders and Host Communities Across the North

our Eminence, it is a public knowledge that your efforts to bring lasting peace and engender confidence in the Northern Communities is well acknowledged not only in Nigeria but the international community. It was not a surprise when the prestigious Time Magazine named you among the 100 most influential people in the world. No doubt, your efforts are well acknowledged across board.

As you are aware, climate change as well as the existence of several international cattle routes from Cameroon, Chad and Niger Republic all passing through several Northern States have been regarded as part of the reasons for the increased hostilities between herders and host-communities. This has made the grazing matter to be of international dimension. The increasing clashes prompted some States such as Ekiti and Benue to ban open grazing as measures to stop clashes between the hostcommunities and the herders. Likewise, more States are likely to key into this trend.

Similarly, there are increasing clashes between host communities and the herdsmen across West African sub-region. In the recent times, several communities continued to be attacked either by bandits, herders/cult groups which resulted to death of hundreds of lives and destruction of properties that cost up to \$13.7 billion annually said former President Abdussalam Abubakar. Similarly, thousands of cattle have been either rustled or killed alongside the herd's men across the West African sub-region.

In addition to several resolutions proffered by His Eminence including addressing issue of climate change, strengthening of boarder security, establishment of by Muhammadu S. Bello sarkiwa@gmail.com

cattle ranches and grazing reserve etc, there is need to provide even more solutions that could be of help to the Authorities across the West African sub-region.

In the hight of mistrust and increasing clashes between host community and herders, there is an urgent need for His Eminence to congregate Northern traditional rulers for a meeting to be conveyed in Kaduna State capital and discuss on mechanisms to implement earlier resolutions as suggested by specialists across the country and beyond with a view to resolving the lingering crises between the herders and host communities.

Due to the international dimension the conflict between farmers and herders have taken, His eminence and other traditional rulers could as well invite the Economic Community of West African (ECOWAS), to the proposed Kaduna meeting and suggest for the establishment of a Short Wave (SW) radio station that could be used to enlighten, educate, preach peace as well as, create opportunities in both

crop, grass and animal farming to herders and farmers using languages used as medium of communication across West Africa such as English, French, Hausa, Fulani, Toureq, Kanuri and others.

The forum could as well invite the New Nigeria Development Company (NNDC) the creation of Northern Agricultural Export Board to guide farmers and herders on best practices and exporting same for increasing profit and economic development.

Lasting peace and harmony between host communities and herdsmen across the North could be achieved when mutual trust and confidence is established with the assistance of both West African Governments as well as the support of both Federal and state authorities in collaboration with various local administrations across the Country. It is therefore expected that, the northern traditional rulers being the custodian of the communities will take it up with the above listed authorities to achieve lasting peace and ensure economic development.





Alh. Yakubu Ladan

Shantali: My name is Yakubu Ladan and I was born in 1966. I started my primary education in 1973 and finished in 1979 and immediately proceeded to secondary from 1979 to 1984. I attended a 1-year course at Staff Training Centre, Funtua, Katsina state from 1989 to 1990. I pursued a Diploma course in Congo Campus of Ahmadu Bello University, Zaria. Presently, I am working at Zazzau Emirate Council with His Highness the Emir of Zazzau, Alhaji Shehu Idris, CFR.

ERMI: In which year did you become the Shantalin Zazzau and what are some of your official responsibilities as well as things facilitating the discharge of your duties successfully?

Shantali: Decades back, Shantali serves as the custodian of a number of Emir's personal effects and secrets, eg. Money, kettle for ablution, tashaha, prayer mat, etc. In fact, the word Shantali is derived from Sintili (meaning secret). But over time these have changed and now only take care of these things

The reason for such interview with people holding diverse traditional title, is aimed at letting the public gain more knowledgeable about the roles and traditional titles as well as their holders. The interview was conducted by ERMI reporters, Adamu Muhammad Jah Jah (07062681871) and Abdullahi Ja'e (08032981536).

whenever the Emir is travelling. In addition, I take care of certain messages from the Emir to other people, mentioning to the Emir of awaiting visitor(s) etc. Again, whenever there is a turbaning at the Palace before the Emir, It is me who will kick start the process with the support of Shamaki.

ERMI: Who is next to you in ranking and the rest on the line within the circle of the Emir's aides? Shantali: Well, Emir's aides are segmented, there are the senior and the junior ones with their schedule, we have Galadima Stantali, Ciroma, Majidadi and Makamar Shantali, therefore Galadima is next on the line then Ciroma down to the line. So, Galadima acts in my absence first like how the immediate late Shantali Aliyu used to act when our late father Shantali Ladan was faced with some health challenges.

Going by the history, in Zazzau actually the Madaucin was aide to the Emir during Habe rule, who also served as the custodian of Emirship items of traditional authorities (ie. Swords, knife, rowd, mat, etc). But with the advent of Fulani rule, has brought alternating of seniority position. Sometimes, it will be Madaucin cikin gida or Baraya or even Shamaki.

ERMI: Where is the originating Emirate of Shantali title and when did it take off in Zazzau Emirate. Again in Zazzau Emirate, what is your position from its inception and other Emirates where Shantali title

Shantali: The title of Shantali took

off in 1804 during the Fulani rule in Zazzau Emirate, and it was Emir Malam Musa who brought two titles to Zazzau, Shantali and Tuta as his close confidants. The first Shantali is Zazzau was Hassan Dan-Kurna who followed Emir Malam Musa (Bamalle). Shantali: Yes, Magayaki in Sokoto, Shantali in Kano, Masu in Bauchi, Mabudi in Gombe, Shantali in Katsina, Bidda and Ilorin.

ERMI: Do you have a call for other aids of Emir's generally?

Shantali: We should remain upright and trustworthy to the core at all times, continue to tolerate people coming to see our Emirs, protect the interests of our Emirs and our Emirates, uphold self discipline.

Finally, I wish to see further strengthening of relationship between us and our children especially through inter-marriages as entrenched by our parents and grandfathers.
