Founding of the (Abuja) Zazzau - Suleja Emirate in the Year 1804 AD

OWARDS the end of the eighteenth century the rising tide of Fulani invasion from the North was productive of the first Habe immigrations,

and at the beginning of the nineteenth century the defeat of the Habe of Zazzau by the Fulani resulted in the transfer of this Kingdom to the country that now comprises the (Abuja) Zazzau-Suleja Emirate.

In the year 1804, it is recorded that Muhammadu Makau or Makam the 55th and last Habe ruler of Zazzau (Zaria), having been completely defeated by the Fulani Emir, Mallam Musa, the first Emir of Zazzau (Zaria) in the Fulani ruling clan fled southwards accompanied by large number of his followers and their women, and sheltered among his vassals the Korau. He eventually settled at Zuba (near the present town of Abuja) and founded the Kingdom now known as the Zazzau - Suleja Emirate. The courtesy title of "Sarikin Zazzau" was retained and is in use to the present day and the chief badge of office is the "Takobi" which is known as "Zazzau" (The Royal Sword of Zaria). A daily

prayer is said to be put up in the mosque to this day imploring the restoration of their ancient Kingdom. After establishing himself firmly at Zuba, Makau gathered round him many more of his former Zaria office-holders (title holders) and retainers with their households and slaves, and was thus enabled to continue to enforce the annual tribute formerly sent to him at Zaria by the Korau and their Gwari vassals. As he waxed in power he enlarged his sphere of influence and even adventured as far as Lapai (Nupe Province) where he besieged the Chief of Lapai,

Daudu Maza, Makau was killed in battle at the gates of Lapai circa, in the year 1825. (Lapai history shows Dauda Maza as ruling from 1830 to 1846, but there is evidence to show that Makau was killed before 1830).



On Makau's death his followers retreated from Lapai and were led back to Zuba by his brother Jatau, nicknamed "Abu Ja" (Abu the Red, from his fair complexion), who then became Chief and built the large walled town which became known by the nickname of its founder, Abuja.

The site of the town was admirably chosen in a well-watered amphitheatre surrounded by high hills and broken country well calculated to screen Abuja from attack by its powerful neighbours on the North and West (Zaria and Lapai, etc.). Close to Abuja is a great rock (Now called 'Zuma' Rock) visible for miles around, and round this rock many legends are woven.

"Abu Ja" reigned for 24 years and completed the building of the town

with its large encircling walls and moat. He died in 1851 and was succeeded by his brother Abubakar, better known as (Abu Kwaka "Dogon Sarki"), who reigned for 25 years. This completed the reign of the three brothers of Makau (or Makam), Abu Ja, and Abu Kwaka sons

of Bako Isiyaku, 54th Emir of Zazzau, who had reigned in Zaria circa from the year 1798-1801 AD. It was during the reign of Abu Kwaka that intercourse was first allowed between Abuja and other Emirates. Until about 1870, no "strangers" had been allowed to enter the country owing allegiance to the ruling house of Abuja.

On the death, of Abu Kwaka in the year 1876 AD, the title reverted to

Ibrahima (Buraima), the seventh son of "Abu Ja" Ibrahima (Buraima) reigned from 1876 to 1902. During this reign the Emir Usman Yero of Zaria, with a numerous force descended on Abuja (circa 1894 AD) and pitched his camp close to the Gwari village of Dikko, some ten miles from the town of Abuja. After a series of forays, Usman Yero

penetrated to Abuja and besieged the town for nearly a month, till in a pitched battle in which the Fulani are said to have lost heavily, he was defeated and retired leaving a large number of horses and much booty in the hands of the Abu Ja Habe.

The Abujas had now developed their forays and brigandage to such an extent, that their influence was felt as far as the River Benue and to its confluence with the Niger, and the great caravan routes from Zaria southwards were unsafe. It was in the southern part of this belt that the Hon. David Carnegie, Assistant Resident, lost his life.

Alhaji Abdullahi Bayero: **The 10th Fulani Emir of Kano**

Ihaji Abdullahi Bayero son of Emir of Kano Muhammad Abbas was Emir of Kano, with headquarters in Kano, Kano State, Nigeria from 1926 to 1953. As a traditional ruler he had extensive powers under the British colonial authority.

EARLYYEARS

Bayero was born in 1299 AH (1881AD). He received his early Islamic education at the Sarki's palace and he was guided by the prominent Islamic scholars of his time.

While he was the Chiroma of Kano and District Head of Bichi he became very closely associated with the prominent Ulama. When the British colonial administrators introduced the new district administrative structure Alhaji Abdullahi Bayero, who was then Chiroman Kano, was appointed the Head of the Home Districts with headquarters at Dawakin Kudu and later (1914) at Panisau. He was appointed as Sarkin Kano in April 1926 and was formally installed on 14 February 1927. Then he was the most experienced contender for the Emirship and had also proved that he was honest, efficient, dedicated and upright.

LIFE CAREER

Sarkin Kano, Abdullahi Bayero made several appointments during his reign, among those he appointed were his sons; Muhammad Sanusi whom he appointed Ciroma and District Head of Bichi, the position he held before his succession of his father, as the Sarkin Kano; and Aminu who was appointed Dan Iya and District Head of Dawakin Kudu.

After the deposition of Muhammad son of Sarkin Kano Shehu Usman from Turaki and District Head of Ungogo he appointed his brothers Abdulkadir and Muhammad Inuwa as Galadima and Turaki respectively in 1927.

He reduced the influence of the "Cucanawa" and also freed all other Royal slaves, which was in line with the British anti

slavery policy. He also delegated s o m e o f h i s e x e c u t i v e responsibilities to his councilors... Emir of Kano Abdullahi Bayero died and left behind 26 children, with Sir. Muhammadu Sanusi Dan Bayero as the eldest and Ado Bayero as the 11th. During his reign, Abdullahi Bayero turbaned members of Dabo clan;

Since when Bayero was alive he turbaned four (4) of his children: 1. Muhammadu Sanusi Dan Bayero as Ciroma.

2. Aminu Abdullahi Bayero as Dan'iya.

3. Isa Bayero as Dandarman (later he was dethroned by his father, Sarki Abdullahi Bayero).

4. Faruk Bayero as Danburan.

Muhammadu Sanusi Dan Bayero after succeeding his



father, he started turbaning his brothers:

 Make as Magajin Malam and later Turaki.
Garba as Danburan.

2. Garba as Danburan.

3. Kabiru as Barde Kerarriya

4. Sani Bayero as Dan buran (later Ado Bayero made him Galadima).

Apart from Muhammadu Sanusi Dan Bayero, Emir Muhammadu Inuwa turbaned Ibrahim Cigari as Magajin Malam (later Ado Bayero elevated him to Barde).

Emir Ado Bayero turbaned eleven (11) of Emir Abdullahi Bayero's sons:

1. Hamidu Bayero as Dan Isa (later Barde and Galadima).

2. Yusuf Bayero as Dan Isa, Dan





On Alhaji Abdullahi Bayero: The 10th Fulani Emir of Kano

Buran, Barde and Dan'iya.Bello Bayero as Dan amar, Danmaje and Danburan.

4. Halliru Bayero as Dan Ruwata.5. Tijjani Bayero as Wakilin Gamma and Wambai.

6. Bashari Bayero as Wakilin Gabas, Danruwata, Dandarman and Dan Isa.

7. Sani Bayero as Yarima and Dan Amar.

8. Idris Bayero as Danburan and Barde.

9. Salihi Bayero as Danburan.

10. Hamza Bayero as Danburan and Sarkin Shanu.

11. Mahmud Bayero as Danmaje, Tafida, Turaki and Barde.

When the above 11 that Ado Bayero turbaned is merged with the 4 that Abdullahi Bayero turbaned, the 4 that Muhammadu Sanusi Dan Bayero turbaned, plus the only one that Muhammadu Inuwa Bayero turbaned, plus the 11 that Emir Ado Bayero turbaned and the remaining 5 that does not hold any traditional title:

1. Dalhatu Bayero.

- 2. Jafaru Bayero.
- 3. Auwalu Bayero.

4. Salisu Bayero and

5. Tijjani Bayero. One will have the total number of 26, which is the total number of Emir Abdullahi Bayero's biological sons.

Indeed, Ado Bayero was a man of honour, as he honoured the entire family of Sarki Alhaji:

1. The Isa Dandarman that Sarki Alhaji dethroned him himself, Ado Bayero returbaned as Wakilin Yamma.

2. The Danburan Faruk that was dethroned by Emir Muhammadu Sanusi Dan Bayero, Ado Bayero turbaned his son, Maitama as Danmaliki. 3. The Dan'iya Aminu that was dethroned by Emir Muhammadu Sanusi Dan Bayero, Emir Ado Bayero turbaned his son, Maikano as Danmakwayo.

4. Barde Kerarriya, Kabiru, his son was turbaned.

5. Tijjani Dandarman that was dethroned by Emir Sanusi Dan Bayero, Emir Ado Bayero returned him as Wakilin Yamma.

In Emir Muhammadu Sanusi's family, Ado Bayero turbaned:

1. Abdullahi Sanusi as Santuraki, Danruwata and elevated him to Dokaji.

2. Sanusi Lamido Aminu Sanusi as Danmaje (in 2012).

As a result of mutual cohesion between Sarki Alhaji Bayero and Galadima Khidir, Sarki Ado turbaned 3 sons of Galadima; Tats as Baura, Tijjani as Danburan and Maizaure as Dan amar.

In Turaki Hashim's family, Ado Bayero turbaned Tijjani as Dan Isa, Turaki, Dan'iya then Galadima, he turbaned Ali Kiru as Yarima.

In Abbas's family, Ado turbaned Garba Abbas As Dan Lawan.

N Emir of Kano Usman's family, he elevated Tafida Mahmud to Wambai, he turbines Sayyadi Ringim as Danmaje and elevated him to Tafida. Ado turbaned Tijjani as Dallatu, Danmaje and Tafida.

In the family of Danmaje, Zakari Dan Majekarofi, Ado turbaned his son, Mukhtari as Dallatu, later Danmaje.

In Dan Isa Muhammadu son of Umaru Sanda's family, Ado Bayero turbaned his son, Mijinyawa as Bunu and later Dan Isa.

In the family of Sarkin Shanu Hassan, Ado turbaned Sa'adu Aminu as Dallatu and later Dokaji.

And many more ...

The late Kano Emir, Abdullahi Bayero (Sarki Alhaji) as popularly called was a son of late Emir of Kano Muhammadu Abbas, the father of Sarkin Kano Muhammadu Sanusi and Sarkin Kano Ado.

Sarkin Kano, Alhaji Abdullahi Bayero died on Thursday 13th Rabi al-Thani 1373 (23rd December, 1953).

The late Emir Ado Bayero widen Kano Emirate by coming up with many Royal titles and honoured those that deserved to be honored before he answered the call of his creator in the morning of Friday, 6th June, 2014 at the age of 85.

Northern Traditional Rulers' Council Summit in Kaduna Identifies Mandate for Peace and Security

ecently, the regional meeting of the Traditional Rulers' Council of the 19 Northern States and FCT Abuja, took place at Arewa House, Kaduna, on Tuesday 30th April, 2019, under the Chairmanship of His Eminence, The Sultan of Sokoto, Muhammad Sa'ad Abubakar CFR, mni, where the emerging political challenges and the threats to peace, and survival in Northern Nigeria were discussed and ways for curtailing them outlined.

The importance of the summit can be seen in the choice of Kaduna as venue and in attendance by both the Kaduna state Governor Nasiru El-Rufa'i, the Secretary to the Government of the Federation, Mr. Boss Mustapha, the Honourable Minister of Defence, Maj. Gen., Mansur Dan Ali Rtd, the Inspector General of Police, Muhammad Adamu and the Director of Defence Intelligence, Avm, M.S. Usman. In attendance also were the Chairmen of the traditional rulers' council and 2 members each from the Traditional Council of the 19 Northern States and FCT Abuja, the Director of Defence Intelligence and the Commissioner for Local Government and Chieftaincy Affairs, Kaduna State.

The meeting has once again, highlighted the need for matching words with action in winning the fight against armed banditry, kidnapping, intercommunal killings, drug abuse, divisions and disunity that currently threaten peaceful coexistence and survival in northern Nigeria.

The main focus of the summit, after deliberations, which were highlighted in a communiqué, was the traditional rulers' support and appreciation for "the effort of the government to establish community policing in collaboration with Traditional Rulers, Community Leaders and Opinion Moulders."

They therefore "set-up a 7 man Royal Committee to interface with the Office of the Secretary to the Government of the Federation and IGP to come up with workable templates," for maintaining peace, law and order and stopping insurgency, violence, drug abuse among youth and women and crime.

The northern traditional rulers identified 13 areas for attention in their communiqué, among which were their call again for "the Federal Government to continue consulting and collaborating with Traditional Institutions, with the view to tackling the security challenges in the North and Nigeria in general."

They reiterated the urgency needed in sustaining "consistent onslaught against bandits in and around communities of Zamfara and other North Western States with a view to stopping them from regrouping and carrying

out their nefarious and criminal activities against innocent and hapless civilian population in the affected communities."

The traditional rulers also appealed that "security agents should deploy more personnel to the rural communities where bandit carryout most of their activities; and equally enhance synergy with the local population, and the traditional rulers for emphasis on intelligence and information gathering with the view to forestalling bandit attacks in Local Communities."

They however lamented that "the security agencies is encumbered by lack of equipment and corruption, stating that "also the system is too slow to responding to distress call," but accordingly "also urged prioritization of personnel welfare."

The traditional rulers suggested also "that the Police should be re-organize to enhance their knowledge of the environment," adding that "the number of Police personnel ratio to population in Nigeria is low and there is need to employ more hands to enhance their operational capabilities."

They emphasised "the need for frequent consultations among traditional rulers across the country and with people in government," urging for the government "to continue to encourage such consultation, exchange of ideas and promotion of community security, mutual understanding and national integration."

Earlier at the opening of the

summit, His Eminence, the Sultan of Sokoto, has emphasised the important roles of Traditional Institution in tackling security challenges, and warned against hate speeches, ethnic and religious bickering and use of innocent youths as cannon folders.

The Executive Governor of Kaduna State, Mal. Nasiru Ahmed El-Rufai urged the traditional rulers "to deliberate with open minds with the view to proffering solutions to the socio-economic challenges facing the North." He stated that "as custodian of culture, there is an urgent need for collaboration between Government and Traditional Rulers to achieve the desired peaceful coexistence among the diverse people of Northern Nigeria."

The Secretary to the Government of the Federation. Mr. Boss Mustapha "thanked the leadership of Northern Traditional Rulers Council of Nigeria for expanding the scope of discussions held in Abuja down to the zonal levels and urged the Royal Fathers to extend the expected outcomes to every household within their domains." He "thanked the Traditional Rulers for the positive roles they played before, during and after the General Election, he lamented that the negative impact of divisive politics and cleavages among politicians is greatly hampering development of the Nation."

The IGP of Police, Muhammad Adamu, stated that plans are underway to recruit 10,000

Police Personnel and also to kick start community policing with Traditional Rulers as critical partners in the establishment and recruitment process. The Defence Minister, Maj. Gen. Mansur Dan Ali Rtdstated that the Nigerian Military is understaffed and overstretched owing to the number of flash points across the country, according to him Egypt, a country of 85million has a personnel of 500,000 force while Nigeria a country of over 190million have 150,000 personnel. In view of this, plans are underway to recruit more personnel to shore up for the shortfall.

Finally, the Council expressed appreciation to the Governor and people of Kaduna State "for always being there for us during our meetings," and also "thanked all invited guests who honoured our call and participated in the meetings especially the Secretary to the Government of the Federation, Mr. Boss Mustapha, the Honourable Minister of Defence, Maj. Gen., Mansur Dan Ali Rtd, the Inspector General of Police, Muhammad Adamu and the Director of Defence Intelligence, Avm, M.S. Usman.

The Council resolved to hold its next Executive meeting in Maiduguri, the Borno State Capital. The Shehu of Borno Alhaji. Abubakar Ibn Umar Garbai El-Kanemi, CFR has graciously accepted to host members of the Council.

Royalty can Protect its Interests only by Embracing Politics - Mukhtar Ramalan Yero

Eminence Royalty International Magazine (ERIM) recently had exclusive interview with former Kaduna State Governor, Alh. Dr. Muktar Ramalan Yero, Dallatun Zazzau as he clocked 5 years as Dallatun Zazzau (April 2014-April 2019) and also celebrated his 51st birthday (April 1968 - April 2019). In this second-part of the interview, the former Governor explains how life has been so good to him and the challenges he had in service as Governor and in contesting elections and losing and the lessons learnt. Below is part two of the interview in its depth and focus on the issues about which the former Governor spoke with candour and reflection:

ERIM: You became royal title holder of Dallatun Zazzau and member of Zazzau Emirate Council, how did you assume that position? Did you look for it?

Mukhtar Ramalan Yero: Actually, I didn't look for the title of Dallatun Zazzau, because at that time when I was the Governor, the late Dallatu, Muhammad Tajuddeen and I were from the same area. When he died, some people approached me and asked why shouldn't I go for it? I said no, allow me to deal with what I am doing now. But as time went by and people started doing the talking on my behalf. I didn't do it. My relationship with the Emir of Zazzau was very cordial, if I wanted, I could have talked to him, but I didn't talk to him. I didn't tell anybody that I was interested. Even at the time that it was accepted that I should be the Dallatun Zazzau, even the people that wanted me to be had to use the medium in such a way that I can't say no. The people that talked to me were people of high regards and esteem. There was nothing they can ask of me and for me to say no to. So, when they came and said, "This is the situation," I said, anything they want from me, and I can do, I will do for them. That was how I became the Dallatun Zazzau.

politician, how did you find yourself within Zazzau royalty?

Mukhtar Ramalan

Yero: Let me correct you. I'm not a professional politician because I don't regard politics as a profession. I am a professional Accountant, not a professional politician. But I am a politician. I became a politician by accident, and by the Will of God. because I didn't have any political ambition. I didn't have interest in politics. All I wanted was just to practice my profession and then move on. But I found myself being Commissioner of

Finance, Deputy Governor and then Governor, so there was no way I cannot play politics. Now that I am in politics, I look at politics as a hobby, you play your time, and when your time is up, you leave the scene. To me, politics is not a profession, but we are trying to see that we encourage people to be part of politics because it is about aspiring for leadership. So if you want to be a leader for the people, you have to be part of politics.

ERIM: In your view, is there any link between the royal circle and

the political arena?

Mukhtar Ramalan Yero: They always said that royalty should not play politics. I disagree totally with that because politics is about people. Royalty is about people. If you are an Emir, you work for the people. Politicians in one way or another are under the Emirs; they are the Emirs' subjects. Royalties know that as royalty, they have feelings and preferences; the difference between them and politicians is however that as royal fathers, they bless everyone, and encourage their people to choose the best persons that will

lead them, not any person that wants to be a leader. A lot of people aspire to be leaders, but it is not everybody that will be a good leader. Royalty should be involved in identifying people with best contributions to the s o c i e t y a n d t h e b e s t relationships with the people, in terms of support, assistances and respects for the people. But when you say royalty should not be part of politics that is why the royalty is suffering neglect from the politicians.

I don't see any reason why people from the royal families or people from the traditional institutions should not be part and parcel of the political terrain and be in politics to ensure that their interests are protected. In the First Republic, the Sardauna of Sokoto, Sir Ahmadu Bello, who aspired to be the Sultan of Sokoto, became the Premier of Northern Nigeria. Even the late Emir Sunusi was part of politics. In Zazzau, Turaki Ali was part of politics, the Magajin Gari was part of it.Turaki Aminu Tijjani and so many other royalties are all part of it. Now that other members of the royalty are not there, their interests are not being protected. If royal members of the traditional institutions who are not in politics continue to avoid politics, people will be surprised one day, about what politicians can do to them. It has already started.

ERIM: What motivated you to become the flag bearer of your political party during the just concluded 2019 elections?

Mukhtar Ramalan Yero: Initially, I had no intension of contesting in 2019, because it is not easy for the one on seat to contest and lose. The whole blame will be on you from your political party and from people in government, despite roles everybody played. Everybody will downplay their roles and accuse you and abuse you for being the cause of their failure. I suffered that. I said I will allow people to learn and I will allow things to settle. So, I wasn't expecting that I will be part of the political scene sooner in 2019.

I was accused by the EFCC of money laundering over the 2015 Presidential Elections Funds (I don't want to say much about it because the matter is in court), as a result of which I was taken to prison for six days though there was opportunity for bail. What happened in the prison, from morning to evening, the kind of people that went to that prison to meet us made me felt that, yes, people had really sympathised with us. On the day we were given bail, the kind of crowd that gathered even though it was fasting period, was amazing. People were there right from subhi (before sunrise morning prayer), up to the time we went to court. The crowd was so fantastic and followed us up to the time we were released and went to our houses. The people still followed and remained there. So I said, if the people are still interested, why shouldn't I try? So I came out for the election not because of myself, or because I had something that I wanted to go and pick in the Government House, but because I am interested in what the people are interested in

ERIM: Do you have any plan for re-contesting in 2023?

Mukhtar Ramalan Yero: We leave that to Allah, because number 1, you have to be alive in 2023.

ERIM: For how long have you been turbaned Dallatun Zazzau and had been with Zazzau Emirate?

Mukhtar Ramalan Yero: I was turbaned in 2014, that's about five years now

ERIM: How do you see your relationship with His Highness, the Emir of Zazzau, when you were the Kaduna State Governor?

Mukhtar Ramalan Yero: My relationship with the Emir of Zazzau was there even before I became the Governor. I have a very cordial relationship with the Emir of Zazzau because the Emir of Zazzau has a verv cordial relationship with my father. I also knew that the Emir had a very good relationship with Architect Namadi Sambo when I was Deputy Governor. Even After I became Governor, the cordial relationship continued. It is a normal relationship of a father and son.

ERIM: Thank you, Excellency. We are grateful to you for granting this exclusive interview despite your tight schedules.

Mukhtar Ramalan Yero: Thank you very much. I wish you success. Our doors are open, and we shall patronise you by the Grace of Gods

ERIM: Sir, how do you briefly and precisely introduce yourself?

Muktar Ramalan Yero: My name is Mukhtar Ramalan Yero. I am an indigene of Zaria local government of Kaduna state. I am from Unguwar Kaura in Zaria. I was born in 1968 to the family of Alhaji Ramalan Yero, the Turakin Dawakin Zazzau. My mother's name is Fatima.

ERIM: Give us brief on your early education.

Muktar Ramalan Yero: The normal thing in Zaria was that

everybody started schooling by going to Qur'anic school. I started western education in LEA Primary School, Kaura, where His Royal Highness, the Emir of Zazzau, Alhaji Idris, was the first headmaster of that Primary

School. I left in 1979-1980. I went to the Government Secondary School Ikara, in Ikara Local Government of Kaduna State. We were the first set of that school. We didn't have seniors. I was a Class Prefect/House Prefect right from Form One to Form Five. In the Primary School, I was the first class Captain/Class Monitor right from the Class One up to Class Five. Then I became the school's Time Keeper.

In 1985, I left Government Secondary School Ikara to Ahmadu Bello University, Zaria, where I studied diploma

in Banking from 1986 to 1988. From 1989 to 1991. I studied BSc Accounting in the same Ahmadu Bello University, Zaria. Later, I had Masters of Business Administration (MBA) in the same institution. I also went to Nigeria College of Accountancy, Jos, where I did ANA: that is, the Association of National Accountants of Nigeria course. Right now, I am a fellow of that institute. Accountancy is my profession.

ERIM: tell us about your work and career.

Muktar Ramalan Yero: I started career work with the Ahmadu Bello University Zaria in 1992, after NYSC in Ogun State in 1991-1992. My career work in 1992 started in the Bursary

Department of Ahmadu Bello University, Zaria. After 10 months, I moved to Nigeria Universal Bank. I was there up to 1997, when I joined Nalado Nigeria Ltd., as Chief Accountant. From 1997 up to 2007, I was at Nalado Nigeria Ltd., rising from Chief Accountant up to the Director, Finance and Administration. I left Nalado Nigeria Ltd in 2007 eminence Royalty

and joined the services of the Kaduna State Government as Commissioner of Finance. In 2010, I became the Deputy Governor, Kaduna State, then in 2012, I became the Governor, after the demise of the then Governor, Sir Patrick Yakowa. I was turbaned Dallatun Zazzau in April 2014, when I was the Governor of Kaduna State.

ERIM: what about professional bodies and association?

Muktar Ramalan Yero: I am a member of so many professional bodies.

ERIM: you celebrated your 51st birthday recently, what is the secret behind the dynamic challenges you found yourself in within over 5 decades?

Muktar Ramalan Yero: life is so simple, so difficult, but it is highly interesting. It depends on how you look at yourself, and how you conduct yourself. In these 51 years of existence in this world, I can say that right from the time one finishes secondary school, one is under the care and guidance of parents. But by the time you joined higher institution, you begin to feel a sense of owning yourself to the extent that you have more freedom than before. It is left for you to pursue your future brightly or neglect it and then you regret it.

I am happy that the kind of training I got from my parents, Alhamdulillah, (Praises be to Allah) I am grateful to them for setting me up to pursue my future. After finishing schooling, I did not spent up to two months after graduation and NYSC, I got a job. Since the time I got the job in 1992, I have been moving from one point to another. That is the interesting part of it. But the most interesting part of my life in the changes that I have seen was in 2006. I was Director of Administration and Finance of Nalado Nigeria Ltd when Architect Namadi Sambo decided to contest the Governorship of Kaduna State. That was the time that we came into full politics. I was the only person that Architect Namadi Sambo picked from his organisation to assist him in the political scene.

I have never thought of becoming anything if he win the election, but after winning the election, I found myself being member of the Kaduna State Executive Council. Being a member and having sensitive position as Commissioner of Finance gave me the insight of knowing so much about Kaduna State. I know a lot about Kaduna State. I think that was why. when Architect Namadi Sambo became the Vice President and Sir Patrick Yakowa became the Governor, Namadi Sambo decided to pick me to be Yakowa's Deputy due to the enormous knowledge and respect that we had for each other. So the transformation I had from 2007 to 2015 or to 2012, three years as Commissioner of Finance, two and half years as Deputy Governor and then two and half as Governor, I don't think there is anybody in Kaduna State that has that opportunity.

We can say that, yes, Patrick Yakowa had similar opportunities, after retiring, he became the Secretary to the Government of the State, he became Deputy Governor for two Governors, then he became Governor. But if you look at it still, there are intervals, there are changes between persons to another. But my own, within a period of 8 years I was opportune to serve each year in different positions and capacities as one of the most important Commissioners in the State, then deputy Governor, and then Governor. I think these are some of the changes that I have seen in my life. If you look at it politically, when I joined the service of Kaduna State, I wasn't looking at myself as a politician. I looked at myself as a technocrat, who just came to serve the Government. Eventually I became a Deputy Governor, still I was even reluctant. By the time I became the Governor, I had to accept to be a full politician, because that was what God has chosen for me, and I had to embrace it and I had to see what I can do about it. I am so happy these were some of the challenges; then also to be in service, to contest an election and to lose an election, that one too, is another issue... It is all part of the changes; to contest again and not even getting the ticket of your party because of certain issues. But all these things are by the Grace of God, by Allah's Knowledge, by Allah's Wisdom by Allah's Acceptance and Approval.

ERIM: Your Excellency how did you managed to govern a cosmopolitan state like Kaduna that is like a small Nigeria?

Muktar Ramalan Yero: Well, leadership is part of the attributes of Allah (subhanahu wa ta'ala) and

He gives whomever He wishes to give at the time He wishes. If you become a leader the first thing that you should do is to seek Allah's help. With Allah by your side, everything will be alright. One of the secrets also is that I rested my case; I submitted myself, total submission to Allah, and sought His help, His Guidance. That was why we were able to succeed.

ERIM: Shortly after succeeding your predecessor in 2010, you became more popular and champion of Kaduna State people to the extent that the masses used to block your convoy for them to identify with you and to show their allegiance. What is the secret behind that?

Muktar Ramalan Yero: Allah (subhanahu wa ta'ala) is the secret.

ERIM: Excellency, you became a giant of the strides among your peers and attracted many politically. What was the secret?

Muktar Ramalan Yero: All these were attributed to God Almighty Allah because there was no way one could earn all these things without Allah being on your side. There was no amount of money to give to get what was gotten. There was no amount of whatever you think of was, so everything was Allah's Design, we are only followers.

ERIM: What were your challenges then as Deputy Governor of Kaduna State?

Muktar Ramalan Yero: Well, if I had not been Commissioner of Finance, maybe I wouldn't have understood what the Deputy Governorship was all

about. Deputy Governor is a position where you have to be extremely patient. If you are not a patient person, there's no way you can succeed as Deputy Governor. Deputy Governorship position is a position that does not have a schedule. You don't have anything to do. What your Governor directs you to do is what you are going to do. If you are not patient, you would not be able to succeed as deputy Governor. So, the challenge was that, I was the Commissioner of Finance in a position where everything around the Governor was centred on me. But as Deputy Governor, I found myself in a position where I was totally neglected. Nobody wanted to talk to you; nobody wanted to listen to you, so it was not an easy issue.

Interestingly, it was like a Canadian High Commissioner I knew put it. His office was in Canadian High Commission, Lagos. When I was Commissioner of Finance, we were coordinating Canadian Law with some banks, so we used to meet in his office. Later, he was transferred back to Canada, When I became Deputy Governor, I was in Canada for the World Mining Organisation International Conference (I was a member of World Mining Organisation), and we met. The first thing he said to me was, "Mr. Yero, I learnt that you are now Deputy Governor of Kaduna State." I said, "yes." He just said, "what a demotion!" I was surprised why this man said it was a demotion. He said, "yes, it was a demotion because deputy doesn't have a schedule, you don't have anything, you cannot do anything, but as Commissioner of Finance, everybody and everything was centred on you." So to me, being Deputy Governor was a

demotion. That was what the Canadian man said. Of course it was not a demotion per se, but a demotion in term of schedule: that you don't have a schedule, that you can't do anything. People think that you have convoy, you have security, you are being called Excellency and everybody thinks that, "yes, you can do." But not so. To me, the challenge of a Deputy Governor's office are many: your enemies will not like you because they will always criticise you for not doing this or that, and even those who are with you, will start to criticise you for not helping them, but there was no way you could do anything for them as they wanted.

ERIM: What were your experiences as State Governor?

Mukhtar Ramalan Yero: It wasn't difficult for me to fit into the office of the Governor because I had lots of knowledge about the government when I was Finance Commissioner, and also when I was Deputy Governor. The only thing was that as Deputy Governor, lots of people you were working with didn't like you, didn't want to talk to you; they always undermined you where they were not treating you nice. But now that you became the Governor, all those people now wanted favours, wanted to respect you. This was a very big experience compared to transiting from a situation where you were a non-entity, to transition to where you were the Alpha and Omega: everybody wanted to talk to you, everybody wanted your favour, and everybody wanted you to do this and that.



Sokoto Caliphate and the Birth of Three Dynasties in Zazzau Emirate

azzau was the most southerly of the original Hausa States. Between it and the River Benue lay a belt of country which differed from the open plains of the north by being more hilly and having a denser cover of bush. This area contained no important States, apart from Nupe in the southwest, and its population was grouped into a number of petty principalities and independent pagan tribes. In the seventeenth century they were all embodied into the riverain empire of Kwararafa, while Zazzau itself was threatened and constricted, but as the Jukun power receded again, so a power-vacumn was created into which Zazzau was able to expand.

In the north the expansion of the Hausa States had already taken the form of settlement, plantation, or conquest followed by assimilation. In the south, however, the denser bush did appeal to Hausa settlers and the more primitive tribes were no assimilate. e a s y to Consequently, Zazzau's expansion proceeded by cõnquest and the imposition of suzerainty, not by settlement or assimilation, and the pattern which emerged from it differed from the conventional one. By the end of the eighteenth century there were, in fact, five petty Chiefs on Zazzau's southern borders who ruled over

congeries of Gwaris, Bassas, and other small tribes and tribal fragments. All these Chiefs owed allegiance to Zazzau and were



subject to loose control by the Hausa Chief. Provided that they paid their tribute of slaves, however, they were largely left to their own devices.

In addition to these vassals, there were other tribes which had never made submission. Having refused to purchase their immunity by doing homage and paying tribute, they were regarded by the Hausas as fair game for the slave-raids by which Zazzau traditionally supported itself and provided for the needs of the rest of Hausaland.

In 1802 Muhamman Makau succeeded as the sixtieth Chief of Zazzau."He was a devout Moslem and when, after the jihad had begun, Shehu's message was brought to him, he was ready to accept it. His advisers thought otherwise, however, and he was compelled to defer to their views. As Zazzau had apparently not followed Gobir and Katsina in renouncing its allegiance to Bornu, and as the suzerain's influence seems to have been stronger there than in the other Hausa States, it may well be that Makau was coerced in this matter by the Kachalla, the Sultan of Bornu's Resident at his Court, or perhaps by an alliance between Kachalla and his own the Councillors. Whatever the process might have been, the outcome was that Shehu's overtures were rejected and the war spread.

The principal leader of the jihad in Zazzau was a Fulani called Mallam Musa who hailed originally from Mali, in the western Sudan. He had come to Hausa land some time before and. after studving under Shehu, had established himself in Zazzau as a religious teacher. He is said to have taken part in the flight from Degel to Gudu and he certainly received a flag from Shehu with a commission to lead the jihad in Zazzau.

The Fulani had been established for generations in Zazzau, as in the other Hausa States, and Musa's appointment as leader seems to have caused some jealousy among the older families. Prominent among these were another branch of the Sullubawa, whom we have already met in Katsina and Kano, and the Bornawa who, as their name shows, were Fulani who had come to Zazzau by way of Bornu. Musa was instructed by Shehu to work with their leaders, Abdu Salami and Yamusa, and this he did.

In the month of March, probably in the year 1805, Musa entered Zazzau from the north. No doubt he had previously arranged a rendezvous there with Shehu's known adherents. In addition he received support from some of the local Hausas.

As soon as he heard of the invasion, Makau sent his cavalry, under the Madaki, to intercept the enemy and bar their way to the city.

Musa either defeated this force or else gave it the slip, for very soon afterwards he was able to take the Hausas completely by surprise. It happened to be the day of the Lesser Sallah festival and the Chief, attended by his followers and accompanied by all the Moslems of the city, had ridden forth as usual to theEid prayerground outside the walls. While there, they were surprised by Musa's cavalry and their retreat into the city cut off. Being unarmed they were unable to stand and fight and so they had no choice but to fly. The great city of Zaria, therefore, fell to the Fulani with hardly a blow having been struck.

Having lost his capital Makau made his way south with about three thousand followers. He went first to Kauru, but the Chief, who was one of his vassals, shut the gates of the town against him. He therefore passed on to Kajuru where the Chief admitted him. The Fulani were close on his heels, however, and besieged him there for six months. In the end their pressure became so great that he was forced to move on again.

From Kajuru, Makau went on to Zuba. The Fulani continued to attack and harry him for the next fifteen months, but in the south the terrain was more hilly and less open than in the north and they failed to kill or capture him. Finally, in 1807, he repulsed them whereupon they abandoned the pursuit and went back to Zaria.

When he became a fugitive. Makau found that some of his subjects, notably the Gwari, remained loyal to him but that most of them threw off their allegiance. Having no capital or base of his own, he was forced to keep moving about in the broken country which lies between the Niger and the Benue Rivers near their conflunce. In this way he preserved a precarious existence for another eighteen years. In 1825, however, while attacking the town of Lapai, he met his death.

Makau was succeeded by his brother, Abu Ja. It was he who founded the town of Abuja and this became the headquarters of the fugitive Hausas of Zazzau. They continued to maintain their independence and, by exerting their influence over the neighbouring pagan tribes, gradually built Abuja into a Chiefdom of some importance. For the rest of the century they were to remain a thorn in the side of the Fulani, but they never developed into such a serious menace as the diehards of Gobir. Katsina, and Kebbi were soon to become.

Meanwhile, Mallam Musa had been confirmed by Shehu as the first Fulani Emir. His first task was to consolidate his authority in Zazzau proper and its vassal States. After the flight of Makau there seems to have been little resistance from the Hausas. The feudatories and major office holders fled or stepped down into obscurity. Either way, the road was left open for the new Emir to install his own supporters, the great majority of whom were Fulani.

Musa was not content with consolidation, however, and was determined to extend his dominions southward. This he did by inducing the Fulani in the area, who were

already fighting the local pagan tribes, to accept his leadership. The Fulani of Jema'a seem to have been glad enough to do so in return for Musa's promise of protection and support. Those of Keffi, where Abdu Zanga had already established a town protected by a stockade, were at first hopeful of obtaining recognition direct from Shehu, but Musa persuaded them that Shehu had already made him suzerain of all the territory between Zaria and the Benue River. In the end, therefore, they were content to accept a flag from him and acknowledge him as their overlord. In this way the two small Emirates of Jema'a and Keffi came into being in about 1810 as vassals of Zazzau. Nearly a generation later the process was repeated when Makama Dogo, a Hausa soldier of fortune who had carved out a kingdom for himself in the south, was recognized as the vassal Emir of Nassarawa. In this way, Zaria, as the Emirate of the Fulani now came to be called, at length reached the Benue.

When Musa, the first Emir, died in 1821 one of his sons expected to succeed him. In the event, however, the choice of the Electors fell on Yamusa, the head of the Bornawa family, who as the Madaki had been

Musa's principal lieutenant. Similarly, when Yamusa died in 1834, the throne did not go to any of his sons but to Abdul Kerim, another Fulani who had played a prominent part in the jihad. After that, apart from one aberration, the succession rotated irregularly between the houses of these first three Emirs. This meant that Zaria had three ruling families whereas in all the other Emirates, including Kano after the initial change, there was only one dynasty. Cont'd from pg 18



EMRI: What is your position as regard the one and only officially recognized district left in the entire Kauru Emirate?

Galadiman: Well, we regard the situation as the will of Allah and the governor who in his wisdom knows why it is inevitable to carry out the restructuring of the traditional districts of the state. We will continue to agitate for more district heads, looking at the important role they play especially in the maintencance of security.

After a brief research and series of consultations, I found it very important to summarize and share this piece of history.

Abubakar Muhammad Musa (Saraki)

heikh Usmanu Bin Fodiyo popularly known as "DAN FODIYO" or "SHEHU DAN-FODIYO" had 17 or 18 sons, 5 of which formed the major Royal houses of the Sokoto Dynasty. His Islamic reformation, his conquest, his teachings and his leadership powers spread all over Hausa/Fulani land ranging from Northern Nigeria, to Niger Republic, Burkina Faso, Mali, Northern Cameroon, Part of Chad, and parts of Senegal, Gambia and Gabon. He was after the 1804 jihad unanimously conferred by all the regions under his control as the 'Amir-ul Mu'minin' (Commander of the faithful), the title which was later referred to as the SULTAN. Not until after the invasion of W/Africa and the disintegration of Hausa land by the European colonies that the powers of his successors were later limited to Northern Nigeria alone. His 5 sons that formed the 5 ruling houses of the Caliphate are listed below, indicating the districts

1. Muhammadu Bello: Descendants rule; Wurno, Rabah, Dange, Goronyo, Isa (Sokoto State), Maradun (Zamfara state) and Kontagora (Niger state)

under their control:

2. Muhammadu Buhari: Rules; Tambuwal, Dogon-daji, Sifawa & Bodinga (Sokoto state)

3. Abubakar Atiku: Rules; Gwadabawa, Illela, Gada, Tangaza (Sokoto state) 4. Ahmadu Rufa'i: Rules; Silame (Sokoto state)

5. Isah Mai Kware: Rules; Kware (Sokoto state)

While his brother Abdullahi bin Fodiyo a.k.a Abdullahin Gwandu was appointed by Shehu as the (Amir) Emir of Gwandu, whose center/HQ was later moved to Birnin Kebbi.

He was at the same time assigned in charge of the affairs of the Western Emirates; Nupe and Ilorin. His descendants also rules Gwandu, Jega, Kalgo, Bunza, Ambursa, Masama, Makera and Kambaza districts (all in Kebbi state).

While the Sultan (Shehu Dan Fodiyo) himself, directly controls and supervises the affairs of all the districts in the present day Sokoto and Zamfara states. The Sultan also serves as the commander of the Islamic faithful and leads the council of all the Emirates of the present dav Northern Nigeria. The position of the Sultan was later elevated by the federal government of Nigeria as the 'President General of the Supreme Council for Islamic Affairs of Nigeria' (SCIA).

Some important points to note:

1- Any family member from all the 5 ruling houses can assume position as the Sultan of Sokoto as it has been the tradition in the caliphate.

2- Family members of the ruling house of Maradun in Zamfara state can at any time assume position as the Sultan of Sokoto, because their great-grand father & founder Mu'alledi is the son of Muhammadu Bello, son of Shehu Usman Danfodiyo.

3- Likewise any family member of the ruling house of Kontagora in Niger State can also assume the position of Sultan of Sokoto, because their great-grand father Umaru Na-gwamatse is the son of Muhammadu Bello, son of Shehu Usman Danfodiyo. Umaru Na-gwamatse was succeeded by his son Ibrahim Na-gwamatse (the conqueror of GWARI), a.k.a. (Na-gwamatse dodon gwari).

4- Sir Ahmadu Bello (Sardauna of Sokoto), the 1st and only Premier of Northern region is the son of Ibrahim Mai-kahon karo (District head of Rabah), son of Sultan Abubakar Atiku-II, son of Sultan Muhammadu Bello, son of Usman Danfodiyo. He (Sir. Ahmadu Bello) also contested to be the Sultan in 1938, but Sultan Abubakar-III was chosen instead.

5- It was during the reign of Sultan Muhammad Attahiru-1 (in 1903) that the British finally conquered Northern Nigeria by defeating the sultan's army at (The Giginya battle) in Sokoto, and the Sultan though refused to surrender finally flee for an exile to the East (Bauchi and Borno), and believed to have died somewhere within Borno. The same year also Sultan Abubakar Sadiq-III was born in Dange (26KM from Sokoto city).

Send your Children to School, Oluwo of Iwo, Osun State tells Herdsmen

he Oluwo of Iwo, Oba Adewale Akanbi, has called on herdsmen in the country not to jeopardise the future of their children by shunning Western education.

Akanbi said the common practice where children of Fulani herdsmen rear cattle during school hours was unacceptable.

The monarch spoke during a visit to Nomadic Primary School in the Fulani-dominated village of Aare Alaasa in Iwo Local Government Area of Osun State, where one of his high chiefs is the headmaster.

Oba Akanbi stated that his dream for the Fulani children in the area was for the children to become successful lawyers, engineers, medical doctors, astronauts, g o v e r n o r s, t e a c h e r s, administrators, journalists, etc.

The Oluwo said the apathy of the Fulani to education portended grave consequences.

He, therefore, called on Fulani herdsmen to send their children to school rather than limit them to the bush to rear cattle.

Akanbi said female children of the Fulani herdsmen had the potential to become great citizens and should not be hawking cow milk during school hours.

He advised the herdsmen to emulate President Muhammadu



Buhari, who reached the pinnacle of his military career and later emerged the President of the country, saying the President did not shun Western education.

A statement on Thursday quoted the Oluwo as saying, "Buhari is the President of Nigeria today and he is a Fulani. He is a role model. The Fulani will be more productive in Nigeria if they give education a priority.

"So, let your children go to bleak."

e Oluwo of Iwoland **Explained Reasons for his Multi-Cultural Conducts**

he Oluwo of Iwoland, Oba Abdul-Rasheed Adewale Akanbi, explained reasons for his multicultural conducts.

He advised people not to misunderstand his motive of adorning an Islamic regalia and answering the title of Emir of Yorubaland, saying it was meant to foster unity through cultural integration.

In a statement by his media aide, Ibraheem Alli, the monarch enjoined other traditional rulers in Yorubaland to see beyond today and work for a united country through an aggressive cultural integration.

He advised his colleagues to challenge the old order, which he said was "characterised by stigmatisation, threat of secession and inhumane killing on a racial claim."

Oba Akanbi said he would continue to use all means to challenge the old order of discrimination that has continued to polarise the nation along tribal sentiment, adding that love, cultural understanding, peaceful co-existence are necessary ingredients for nation building.

He said: "I want those criticising me for wearing an Emir costume and answering to the title of an Emir to see beyond the surface and dig deep for an understanding of my motive. I have explained that the title is not peculiar to the Northern kings. It is an Arabic word and by virtue of the position of Iwo in bringing

Islam to Yorubaland with the presence of the first mosque in the ancient town in 1655, it is in order.

"A responsible monarch is a father to all in any part of the country. Let's forget about the tribal for many years in the North or the East should be able to contest in Hausa and Igboland. Nigeria's political structure should allow political representation by Nigerians from any location once they have been residents of many

affiliation. Through sentiment many valuable lives of Nigerians have been wasted. Many have been killed ignorantly under the guise of discrimination, forgetting that we are all Nigerians.

"Every king is a father to all, irrespective of their location. If you want to be father to all you should accommodate everyone and treat them equally. This will not only promote true democracy, but will also encourage the much desired national unity.

"Discrimination has dragged us so backward politically as well. Our conventional behaviour is retrogressive. Yoruba man resident years in that place. We are still in the dark age. Until my teaching is heard, I shall push my belief to the doors of all authorities.

"Regrettably, discrimination has posed a monumental challenge to our national growth. Many lives are lost on a daily basis on this. Must it continue like this? Hence, the urgent acute need for cultural integration by the traditional institution. Every king in Nigeria should be able to relate with Nigerians irrespective of religious and ethnic affiliation. We are one. I have Fulani, Hausa and Igbo in my domain. They are all my children. I'm an Emir to the Hausa in my domain, Igwe to the Igbo and so on."




